

Admission Scheme for the Second Generation of Chinese Hong Kong Permanent Residents

一、 Introduction

This page sets out the entry arrangement for persons who wish to enter/stay in the Hong Kong Special Administrative Region (HKSAR) for employment under the “Admission Scheme for the Second Generation of Chinese Hong Kong Permanent Residents” (the Scheme). Regardless of industry, applicants under this scheme are not required to obtain employment in advance when applying to come to Hong Kong.

This Scheme is not applicable to applicants who are nationals of Afghanistan, Cuba, Laos, Korea (Democratic People’s Republic of), Nepal and Vietnam.

二、 Eligibility Criteria

Persons who are the second generation of emigrated Chinese Hong Kong permanent residents from overseas may apply to return to work in the HKSAR under the Scheme. Applicants under the Scheme will have to meet, apart from normal immigration requirements, the following criteria -

- aged between 18 and 40 at the time of application;
- born overseas (i.e. not in the Mainland, the HKSAR, the Macao SAR or Taiwan);
- have at least one parent who is holder of a valid Hong Kong Permanent Identity Card at the time of application and was a Chinese national who had settled overseas at the time of the applicant’s birth;
- have a good education background, normally a first degree, but in special circumstances, good technical qualifications, proven professional abilities and/or relevant experience and achievements supported by documentary evidence may also be accepted;
- proficient in written and spoken Chinese (Putonghua or Cantonese) or English; and
- have sufficient financial means and are able to meet the living expenses for their (including their dependants, if any) maintenance and accommodation in the HKSAR without recourse to public funds.

In general, unless a person has the right of abode or right to land in the HKSAR, he/she requires a visa/ entry permit to work in the HKSAR. While each application is determined on its individual merits, an applicant should meet normal immigration requirements (such as holding a valid travel document with adequate returnability to his/her country of residence or citizenship; be of clear criminal record and raise no security or criminal concerns to the HKSAR; have no likelihood of becoming a burden on the HKSAR, etc.) as well as the relevant specific eligibility criteria detailed

above before he/she may be considered for the grant of a visa/ entry permit. It should be noted that the eligibility criteria may be subject to change from time to time without prior notice.

三、 Process

1、 Confirm receipt of application	An application confirmation notice will be sent to the applicant within 7 days of receipt of the application. (issued by immigration)
2、 Issuing the 《Notice of Approval》	Approval takes about 7 days. If the application is approved, you will receive an "Approval Notice". (issued by immigration)
3、 Issuance of visa/ entry permit	The visa/ entry permit label can be collected by the applicant, or an agent, at the Immigration Department and forwarded to the applicant. (issued by immigration)

- e.** Photocopy of evidence of the applicant's relationship with his/her Chinese Hong Kong Permanent Resident parent(s) e.g. applicant's birth certificate
- f.** Photocopy of valid Hong Kong Permanent Identity Card of applicant's parent(s)
- g.** Photocopy of proof of academic qualifications and relevant work experience
- h.** Photocopy of the applicant's financial standing e.g. bank statements, savings accounts passbooks, tax receipts and salary slips
