Canada's startup visa program targets immigrant entrepreneurs who have the skills and potential to start a business in Canada:

- Be innovative
- Jobs can be created for Canadians
- It can compete on a global scale

To qualify for the Startup Visa Program, you must:

- There is a qualified enterprise
- Obtain a letter of support from the designated organization
- Meet language requirements
- Bring enough money to settle down

The Canadian government does not provide financial support to new immigrants on the start-up visa. When you apply, you need to provide proof that you have enough money to support yourself and your dependences upon arrival in Canada.

## Qualified enterprises meet the following conditions:

- 1 At the time you obtain a commitment from the designated organization:
- Each applicant holds 10% or more of the voting rights of all then issued shares of the

Company (up to five persons may apply to become owners) and

• The applicant and the designated organization jointly hold more than 50% of the total voting rights attached to all the then issued shares of the Corporation

2 At the time of your permanent residence:

- You provide active and ongoing management of the business within Canada
- A significant part of the business operations takes place in Canada
- The enterprise is incorporated in Canada

Obtain a letter of support from the designated agency:

You must obtain a letter of support from a designated organization (venture capital fund, angel investment group, business incubator) (business group that has been approved to invest in or support possible start-ups).

You will need:

- Contact the designated organization to find out how to get its support
- Convince the organization that you have a business idea worth supporting
- Obtain a letter of support from the designated organization

#### Meet the language requirements

- 1 The ability to communicate and work in English, French, or both languages will help your business succeed in Canada.
- 2 · You must take a language test from an approved institution and attach the results to your application (meet the minimum level of the Canadian Language Benchmark (CLB) 5).

- Declaration of separation for minors travelling to Canada [IMM 5604] (if applicable)

#### Two interview options

#### Within Canada:

- 1 Make an appointment at one of our offices in Canada (best option)
- 2 Travel to a Canadian "port of entry" (border crossing) and present:
- Prove that you have sufficient funds to support yourself and your family
- Your Confirmation of Permanent Residence (COPR) and your Permanent resident visa
  (if we have given you one)

#### Outside of Canada:

Upon arrival in Canada, you will be greeted by an officer from the Canada Border Services Agency (CBSA)

- 1 Valid passport and/or travel document
- Your passport must be an ordinary private passport. You cannot use a diplomatic, government service or public Service passport to immigrate to Canada.
- ② Valid permanent resident visa and your Confirmation of Permanent Residence (COPR)
- The officer will ensure that you enter Canada on or before the expiration date shown on your visa (this document cannot be extended)
- ③ Proof that you have enough money to support yourself and your family upon arrival in Canada

### During the interview, the officer will:

- Make sure all your documents are valid
- Ask you a few questions to make sure you are still eligible for immigration to Canada
- Confirm your Canadian mailing address so that we can mail your Permanent Resident
  Card (PR card)
