Canadian Federal Self-Employed Persons Program Immigration

The Canadian Federal Self-employed Person Immigrant program applies to applicants who have relevant experience in cultural activities or sports, and the federal government allows such applicants to become permanent residents of Canada in the form of self-employment, with the intention of contributing to Canada's cultural or sporting endeavors. Athletes, actors, writers, painters, as well as self-employed piano teachers, dance teachers, yoga instructors, etc., can apply for Canadian immigration through the program.

Canadian federal self-employed immigration is a one-step immigration program, there are no mandatory requirements for language and education, visa officers pay more attention to the applicant's experience of self-employment with skills, as long as the minimum score of 35 points is eligible to apply.

Application Requirement:

- 1. The applicant must have relevant experience in cultural activities or sports, which requires the applicant to:
 - a. Have participated in, or are self-employed in, world-class cultural or sporting activities;
 - b. At least 2 years of relevant experience in the 5 years prior to submission of the application:
 - Two one-year periods of self-employment experience in cultural or sports activities; or
 - Two periods of one-year experience in world-class cultural or sporting activities; or
 - One year of self-employment in cultural and sporting activities plus one year of participation in world-class events;
- 2. Willing and able to engage in self-employment in Canada;
- 3. Meet the Canadian federal scoring criteria for self-employed immigrants, with a minimum of 35 points out of 100, mainly based on the applicant's relevant experience, education, age, language level and adaptability;
- 4. Applicants and their families must pass a medical examination, be able to provide proof of no crime, and have sufficient funds to settle down.

Scoring standard

The Canadian federal self-employed immigrant score is based on the following three factors: the documentation provided by the applicant, the score under the scoring criteria and whether they meet the definition of self-employed person, the applicant may be asked to interview during the process to explain unclear or inconsistent information, and the issue of application information gaps.

To apply for self-employed immigration to Canada, you need to submit the following documents:

- 1. Proof of self-employed experience: Applicants are required to provide evidence that they have at least two years of self-employed experience in their own industry.
- 2. Business Plan: Applicants are required to prepare a detailed business plan, which should include information about their business objectives, market research, competitor analysis, marketing plan, financial projections, etc.
- 3. Language test results: Applicants are required to demonstrate their language proficiency by passing a language test recognized by the Government of Canada, such as IELTS or CELPIP.
- 4. Proof of assets: Applicants are required to provide proof of assets that demonstrate their ability to independently operate a business or perform their own work in Canada.
- 5. Education proof: the applicant needs to provide his own education certificate and occupational management quality.
- 6. Passport or identification: Applicants are required to provide a valid passport or identification document.
- 7. Other documents: The applicant also needs to provide some other documents, such as marriage certificate, divorce certificate, children's identity certificate, etc.

It is important to note that the specific requirements for documentation may vary depending on the individual circumstances of the applicant. When preparing the application materials, applicants should carefully study the application requirements of the self-employed Immigration Policy and provide the required documents in accordance with the official guidance.

If you are dishonest in your application for permanent residence, we may:

- Your application is denied
- Found out you weren't allowed
- You are prohibited from applying for permanent resident status for up to 5 years

Use of immigration representatives

If you are a representative, <u>learn how to create an account and submit an application on behalf of a</u> client.

If you want to appoint someone to conduct business with us on your behalf, you must

- Submit the <u>Use Representative [IMM 5476] (PDF, 648.31 KB) form</u>
- Sign your name digitally or manually, and ask your immigration representative to do the same
- Upload with your application

Immigration representatives (immigration consultants or lawyers) can

- To advise you and help you pay for your application
- Help you prepare the forms and documents you need to upload
- Answer questions about the form
- Communicate with us on your behalf through their own account

They can't

- Opening a portal account on your behalf
- Electronically sign the application for you
- Log in to the portal using your username and password

After reading the statement, you must be the one to enter your name and click the "Submit" button. This is a legal requirement for your application to be considered "signed" under Canadian immigration law.

If you want to allow us to release the information in your application to people other than you who will not act as your representative, you must

- Submit Authorization to release Personal Information to designated individuals, Form [IMM 5475] (PDF, 593.57 KB)
- Fill out the form and sign it (digital or manual)
- Have the individual you specify also sign
- Upload with your application

Take fingerprints and photos

If you are between the ages of 14 and 79, you may be required to provide fingerprints and photos (biometric information).

Find out if you need to provide biometric information.

- You must pay a biometric fee when you submit your application. Otherwise, you may experience delays.
- Do this as soon as you receive a letter from us telling you to provide biometrics.
- You have 30 days from the date on the letter to do this.

Temporary changes to biometrics

Book your biometric appointment as soon as possible to avoid processing delays.

If you are unable to make an appointment by the deadline for the biometric instruction letter, temporary measures may be taken to help you.

Pay your application fee

In most cases, your fees will include:

Processing fees for you and anyone you include in your application

Permanent residency fee
Bioassays
hird party expense

Biometric cost

In most cases, you will have to pay a biometric fee when you submit your application. Otherwise, you may experience delays. Biometric fees include the cost of collecting fingerprints and digital photos.

After you have paid the biometrics fee through your completed application, we will send you a letter confirming that you need to provide biometric information and where you can go. When you provide biometric information, you must present this letter.

You must provide biometric information in person. If this service is available, be sure to make an appointment. Find a collection point near you.

Third party expense

Depending on your situation, you may be required to pay a third party:

- Physical examination
- No criminal record
- Language test

Photo specification

You will need to provide a photo for each person on your application.

Follow the instructions in the online application to scan and upload both sides of the photo.

Submit your online application

Before submitting your application, please ensure that you:

- Answer all questions
- Sign your application electronically (enter your full name exactly as shown on your passport)
- Include your fee receipt
- Upload all supporting documents

If your application is incomplete, we will reject it. You must fix all errors and then resubmit.
